N.O. 17.10.060 (a) No person may engage in any retail sales transaction as a seller with the city without first procuring an annual sales tax license from the office of the city clerk.

N.O. 17.10.060(c) No sales tax license shall be issued to or renewed for a person who is required to have a state business license registration or permit, until that applicant submits evidence (1) that he or she has in his or her possession, or has applied for, the state business license, registration or permit; and (2) that all license, registration and permit fees have been paid current. A licensee, registrant or permittee whose fee falls due annually shall have 30 days after the fee date in which to submit proof that the state license, registration or permit has been obtained. **No sales tax license may be issued to or renewed for a person owing a judgment, delinquent taxes, or a utility bill to the city, except by terms and conditions established in each such case by the city manager.**

N.O. 17.10.060(d) There shall be a fee of \$15.00 with the **original** application for the sales tax license. The license shall be renewed annually by February 1 upon payment of a fee of twenty-five **(\$25.00) dollars and completion of a renewal** form as provided by the City Clerk. The sales tax license shall be non-transferable. (1/1/01)
