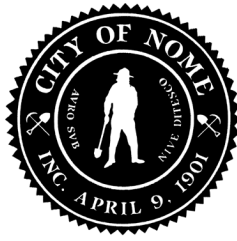

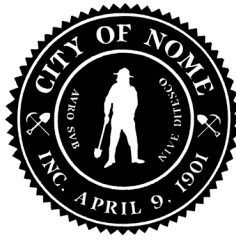

Dear Mayor Hughes,

On behalf of the Norton Sound Economic Development Corporation (NSEDCE) Board of Directors, I am pleased to announce a 2025 Community Benefit Share (CBS) distribution of \$250,000 for each NSEDCE member community. NSEDCE reaffirms our commitment to our member communities through our CBS program which provides financial support to address your community's highest priorities.

The NSEDCE board and staff are aware of the need to ensure accountability of not only how NSEDCE funds are spent, but also the process by which the use of those funds is determined. I stress the importance of—and my appreciation for—your proactive approach to help ensure that all residents of your community are aware of the decision-making process for the use of these funds.

With an emphasis on self-governance and accountability, NSEDCE requires that the following guidelines be met in order to access the funds:

1. The City of Nome (City) must facilitate a public process at the municipal level to determine the highest priorities and best uses for the funds. The public process can be a regularly scheduled or special city council meeting or a special community meeting to address the best use of the CBS.
2. The City must report to NSEDCE on how the funds will be utilized by submitting a letter, detailed budget, and the city council meeting minutes from the session at which CBS funds are approved.
3. The City must expend all prior years' CBS funds before accessing funding from the 2025 CBS.
4. Reimbursements must be only for expenditures made or incurred after the November 5, 2025, award declaration and will be paid on a reimbursable basis or as a direct-vendor payment. Direct vendor payments will only be made for expenditures over \$3,500.
5. CBS funds may not be utilized for payment of bonuses to city council members. If funds are utilized for the payment of standard council member honorariums, or other normal, regular payments to municipal officials, that specific use must be noted at the public council meeting when the share's use is determined and recorded in the meeting minutes.

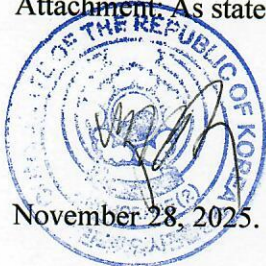

Introduction to Busan Metropolitan City

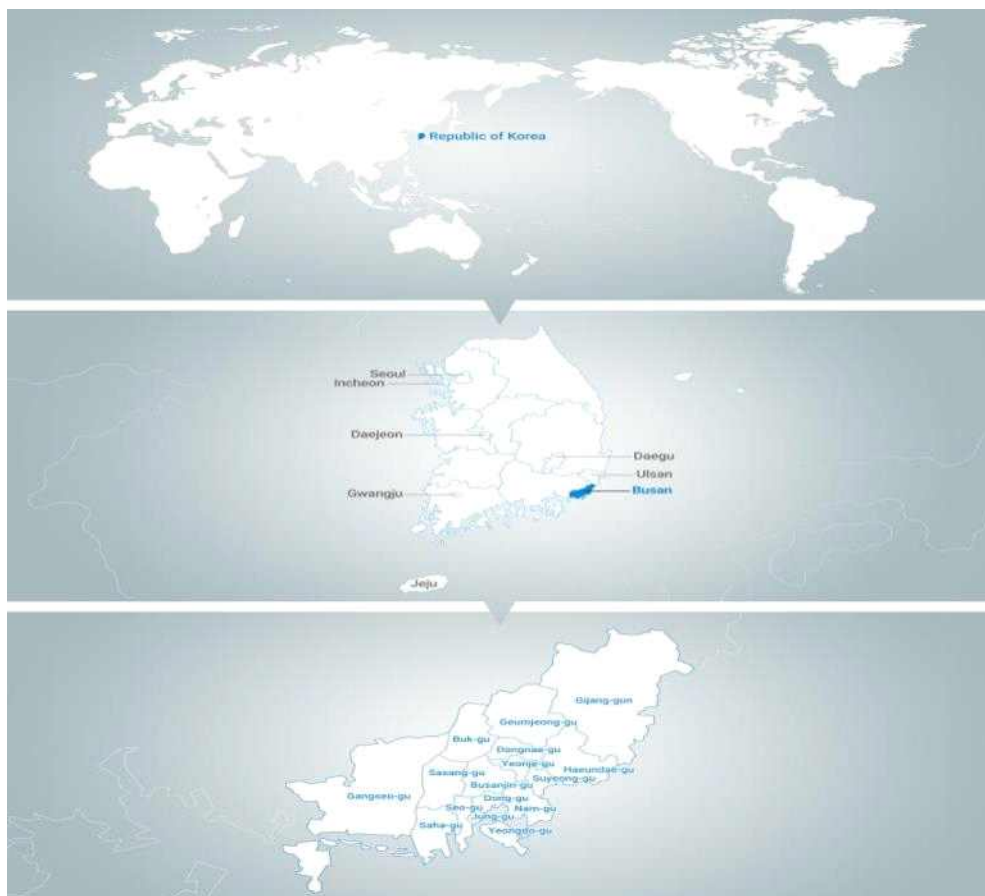


Busan is the 2nd largest city and number one trading hub in Korea, with a population of 3.4 million and a total area of 770.17 square kilometers as of 2022.

Since opening Korea's first international port in 1876, the city has become a hub of trade, commerce and industry

Global events including the Asia-Pacific Economic Cooperation conference, Busan International Film Festival and Busan Fireworks Festival, as well as various sea-related festivals are held throughout the year. The city is also a tourist destination and home to Asia's largest department store, Haeundae beach, and a yacht marina.

Located on the southern tip of the Korean Peninsula, Busan is a historic city that served as the temporary capital during the Korean War and refuge for men, women and children fleeing the North to build new lives.



Nome Comprehensive Subsistence Harvest Survey

Project Objectives

Through household surveys and interviews, this project seeks to document baseline subsistence harvest and use information about fish and wildlife habitats and ecosystem change.

Project Background

Nome is a priority community for a comprehensive survey for several reasons:

- A comprehensive harvest survey has never been conducted in Nome; this is a significant information gap. Comprehensive surveys establish an
- important baseline in advance of pending development projects. As a hub community, the subsistence
- harvesting and use data by residents of Nome is critical to the understanding and characterization of regional subsistence patterns.

Project Partners

Since 1978, the Alaska Department of Fish and Game's Division of Subsistence has documented community patterns of fish and wildlife harvest and use, as well as local and traditional knowledge about fish and wildlife habitats and ecosystem changes.

Project research will be conducted by Division of Subsistence in collaboration with the City of Nome. Community outreach and research will take place in fall/winter 2025 and in spring 2026. This project is funded by the State of Alaska Legislature.

Local Research Assistants

The Subsistence Division seeks community approval of projects from local governments before conducting research. In communities willing to participate in projects, project staff hire and train local researchers to conduct surveys within their own community.

About Subsistence Harvest Surveys

What is a subsistence harvest survey?

Harvest surveys are the best available tool to document the importance of subsistence hunting, fishing, and gathering in the lives of Alaska residents. The Division is required by Alaska state law to collect this information, and we work with local governments to conduct household surveys in the way that works best for the community.

Subsistence research has helped communities ensure continued access to wild foods and the priority for subsistence use.



What is subsistence harvest information used for?

- To help communities demonstrate the importance of subsistence resources and practices to people and their wellbeing
- To establish local use levels which show wildlife managers the importance of subsistence harvests
- To provide a way for subsistence harvesters to report observations and share knowledge
- To establish baselines of subsistence use patterns to understand potential impacts of development projects to subsistence ways of life
- To provide a basis for compensation in the event of a disaster (e.g., oil spill, wildlife population crash)
- To give people a one-on-one way to inform the state of local subsistence practices and concerns

What topics are covered in a survey?

- ♦ Harvest and use:
 - Types, amounts, seasons, and locations of harvests
 - Sharing of wild food
 - How harvests and wild food needs have changed
- ♦ Food security:
 - Having enough food to eat during the year
- ♦ Demographics
 - Population, household size, age, ethnicity
- ♦ Sources of income
 - How money supports subsistence
- ♦ Community questions and concerns

About the household survey process

- ♦ Surveys are **voluntary** and **anonymous**
- ♦ For each survey, we hire several short-term Local Research Assistants in the community

ORDINANCE NO. O-26-01-01**

AN ORDINANCE REPEALING CERTAIN SECTIONS OF CHAPTER 3.10 OF THE NOME CODE OF ORDINANCES TO REMOVE THE REQUIREMENTS OF TAXICAB AND MOTORBUS LICENSING AND AMENDING OTHER SECTIONS OF CHAPTER 3.10 TO BE CONSISTENT WITH CESSATION OF TAXICAB AND MOTORBUS LICENSING REQUIREMENTS.

WHEREAS, the City of Nome currently requires that all taxicabs and motorbuses have an individual license; and

WHEREAS, those licenses are limited to a certain number which is regulated by the Common Council; and

WHEREAS, the licensing process is handled by the city clerk's office and also requires council oversight; and

WHEREAS, it is not evident that the amount of work performed by the city to implement, monitor and enforce the licensing scheme results in increased quality of service to citizens or visitors to Nome; and

WHEREAS, ceasing to require licensing of taxicabs and motorbuses may encourage new operators to enter the market, leading to increased availability of necessary service; and

WHEREAS, a motorbus or taxicab license is not a property interest, but merely a privilege granted for a maximum of a one-year period; and

WHEREAS, there are no current taxicab services in operation that are compliant with local Ordinances; which has prompted the need for relaxed requirements to allow for a more open market and to meet the needs of the citizens of Nome:

NOW, THEREFORE, IT IS HEREBY ORDAINED BY THE COMMON COUNCIL OF THE CITY OF NOME:

Section 1. Classification. This is a Code ordinance.

Section 2. Amendment of Section 3.10.010. Section 3.10.010 of the Nome Code of Ordinances is hereby amended to read as follows [deletions are in brackets and overstruck] new language is underlined:

3.10.010 Operation without license prohibited.

No person shall drive, operate or keep for pay or hire within the city, any taxicab, or motor bus without first having obtained from the city a chauffeur's license. ~~[to drive same, together with the appropriate taxicab or motor bus license for operating or keeping the same for pay or hire, or both of such licenses, as the case may be.]~~

Section 3. Repeal of Section 3.10.080, Section 3.10.090, Section 3.10.095, Section 3.10.100, Section 3.10.105, Section 3.10.107 and Section 3.10.108. Sections 3.10.080 (Motor bus licenses, regulations), 3.10.090 (Taxicab license, regulations), 3.10.095 (Issuance and renewal of taxicab licenses), 3.10.100 (Taxicab identification), 3.10.105 (Denial or revocation of taxicab or motorbus licenses), 3.10.107 (Appeals from taxicab or motorbus determinations) and 3.10.108 (Transfer of taxicab or motor bus license) of the Nome Code of Ordinances are hereby repealed.

Section 4. Amendment of Section 3.10.110. Section 3.10.110 of the Nome Code of Ordinances is hereby amended to read as follows [deletions are in brackets and overstruck] new language is underlined:

3.10.110 Definitions.

~~["Taxicab license, motor bus license" means the permission or license granted by the city to any person to operate or keep for hire, any taxicab or motor bus, as the case may be, within the city, or upon the public streets thereof.]~~

Section 5. Amendment of Section 1.20.040. Section 1.20.040 of the Nome Code of Ordinances is hereby amended to read as follows [deletions are in brackets and overstruck] new language is underlined:

Administration:

Although things are quieter at the port office these days, we are pushing forward on a variety of paths to wrap up 2025, and prepare for 2026. This includes statistical tracking, collections, pursuit of funding opportunities, personnel evaluations, policy change considerations, tariff updates, and improvements to electronic and hard files efficiency.

Causeway:Arctic Deep Draft Port – Port of Nome Modifications (USACE):

Coordination continues between USACE, the City and Kiewit on the required Phase 1A submittals. USACE held an initial pre-construction meeting to introduce the project teams, with other meetings to follow as needed to address RFI's and site work questions. An official pre-construction meeting will be held in Spring 2026, before summer begins. Project partnership discussions are ongoing regarding scheduling and funding of additional phases. In the meantime, engineering and design work continues on Phase 2.

Local Service Facilities (LSF) Inspection Integration:

The LSF team is collaborating with USACE on Phase 1A project submittals and RFI's, and continues to coordinate on Phase 2 dredging, which is currently scheduled to go out for bid in 2026.

U.S. DOT Maritime Administration (MARAD) – Port Infrastructure Development Program (PIDP) Grant Pre-Award:

Things are progressing with the remaining pre-award requirements for this grant. This will allow execution of the \$11.25M agreement, which includes a separate funding agreement for the \$1.025M passed in the FY2025 USDOT budget to supplement the PIDP award to Nome.

Harbor:Inner Harbor CAP 107 Study (Deepen/Widen the Inner Basin):

The Alaska District continues to recommend a General Investigation (GI) Study. Progress has slowed while the team is occupied with Phase 1A of the expansion. An updated package is in prep to further highlight the nature of the issue and delays associated with this project, for the purpose of sharing with the Congressional Delegation.

Snake River Moorage Facility:

Pre-award tasks for this grant award are in progress to address additional NEPA efforts due to the timing of the project permits. We have contracted with PND to complete the necessary consultations, which will commence once USDOT authorize the pre-award expenditure of those costs. In the meantime, efforts to meet compliance on other pre-award requirements is ongoing.

Port Industrial Pad:West Nome Tank Farm (WNTF) - Property Conveyance:

On 5 Dec 2025, the City sent a letter to the 611th USAF Commander at JBER, requesting an updated status, and ultimate transmittal of the property conveyance package to ADEC for final signature. The letter was also copied to the Alaska Congressional Delegation, which will likely trigger inquiries to USAF HQ requesting action.

Thornbush Laydown Site Development (TBS):

The remaining 8-acres of the undeveloped portion of the TBS site has been isolated into 5 sections. We are now evaluating 3 funding opportunities to develop this additional laydown space, in an effort to meet the demand for commercial staging.

Port Rd. Improvements (ADOT Project cost-shared with City):

This state STIP project has been postponed to approximately 2030 to avoid conflicting with the heavier truck traffic during the port expansion, and to facilitate a more productive repair following the project.

FEMA DR4672 Merbok Recover Projects:Seawall Repairs:

Storm repairs to the east end of the Nome Seawall have been budgeted by FEMA, and will be bid out to local contractors to perform the work. A bid package is being developed using the SOW prepared by FEMA inspectors, and verified by City Engineers. Advertising is expected in Feb/Mar 2026, with work completed by 31 July 2026.

Causeway Road/3 Docks Repairs:

Additional road/dock repairs are anticipated to be performed before freeze-up to replace lost material along the road and all 3 Causeway docks. This will meet the scope of work identified from storm damage, reduce future loss, and improve both the subsurface and surfacing in the busiest traffic areas on the Causeway.

Causeway Utilities (under bridge) Repairs:

Nearly all of the storm repairs to the under-side of the bridge have been completed, by the various responsible entities, with the exception of NJUS. Although a portion of their utility line work has been done, several materials are still on backorder with suppliers. As the scaffolding was removed by the USACE contractor, this final portion of the work will be done during winter, when ice provides a more suitable and stable platform for access.
