# **CITIZENS' COMMENTS**

- 1) Nancy Fiskeaux (telephonic) called looking to listen in to the meeting.
- 2) Francine Johnson (telephonic), citing comments on Facebook about miners, suggested not opening the City up to everybody and focusing on those who live in the community rather than allowing outsiders into town.
  - Manager Steckman explained that Governor Dunleavy decreed mining an essential industry to the State of Alaska. He explained the City's approach to protecting the community, working with the hospital to promote testing and quarantining to mitigate virus spread.

# **NEW BUSINESS**

- A. R-20-04-01 A Resolution Awarding the Port Nome Emergency Fuel line Repairs to Seakers, Inc.
  - Manager Steckman and Port Director Baker explained the status of the fuel line, noting that the fuel line might hold for two years or might suffer catastrophic failure sooner. Due to the risks, administration recommended action.

A motion was made by C. Reader and seconded by C. Martinson to adopt R-20-04-01.

#### Discussion:

- Council Members Martinson and Mark Johnson asked clarifying questions regarding the timeline and costs.
- Port Director Baker explained the work would take about a month, require hydrostatic testing and might incur costs relating to COVID-19 quarantine.

# **UTILITY MANAGER'S REPORT**

- A. Activity Report: April 14 24, 2020.
  - Assistant Utility Manager Morton presented his verbal report noting that power and water usage were down about 5 percent recently. He explained the Utility's approach to quarantining essential workers required to overhaul two generators. Assistant Manager Morton gave an update on upcoming DOT projects over the coming years.

# **CITY MANAGER'S REPORT**

- A. Activity Report: April 14 24, 2020.
  - Manager Steckman noted that the Port was expected to open on May 31<sup>st</sup> and explained the City was working with the hospital on a plan to address Covid-19 positive tests on fishing boats. He laid out the plan to slowly open the Rec Center, as well as the likely cancellation of summer league activities. Manager Steckman explained that the Hospital was working to significantly increase rapid testing and that tests would no longer be confined to symptomatic patients. He updated the Council on the Public Safety Commission recommending the City offer the position of Police Chief to Mike Heintzelman, whose contract will appear on the next agenda.
  - Chief Mike Heintzelman summarized the over 500 calls for service the department has received since April 20, noting there were 36 sexual assault cases, 10 of which the Department was awaited results from DNA tests.
- B. Port of Nome Operations and Projects Report.
  - Port Director Baker explained the status of some Port users' plans for summer operations vis-à-vis Covid-19, noting that Port staff was satisfied so far. She gave an update on the Port Causeway bridge and Army Corps of Engineers dredging activities Director Baker explained the status of Launch Ramp Repair project, noting that due to absence of bids submitted, the project would be rebid in the fall.

# **COUNCIL MEMBER COMMENTS**

- 1) Council Member Martinson thanked Acting Finance Director Crowe for her work in putting together the draft budget and presentation. He agreed with other Council Members that the City shouldn't be looking to balance the budget by cutting the Police Department. He noted the need to discuss the status of the landfill and drainage issues sooner rather than later and requested City address previous issues at the Rec Center while the facility was closed.
  - Manager Steckman explained that work had already begun on the saunas.
- 2) Council Member Reader thanked Acting Director Crowe for putting together the budget presentation. She inquired as to the status of the Police Department Audit that had been ordered in October and was still not completed.
- 3) Council Member Topkok echoed previous appreciative comments to Acting Director Crowe. She expressed concern over the high call volumes at NPD, especially relating to domestic violence, and noted that services were available at the Bering Sea Womens' Group to those listening.
- 4) Council Member Brown no comments.
- 5) Council Member Doug Johnson no comments.
- 6) Youth Representative Kenick no comments.
- 7) Council Member Mark Johnson thanked Acting Director Crowe for her work on the budget documents and Chief Heintzelman for piloting NPD through a difficult time. He noted it was good to have Clerk Hammond on the line and wished Mayor Beneville a speedy recovery.
