 - Manager Steckman noted May 18th as a potential conflict, as his anniversary was that week and he was hoping to spend it with his wife.

CITIZENS' COMMENTS

- Tom Vaden, LEPC Chair, thanked the Council for supporting the LEPC through NSEDC CBS funds. He described some of the LEPC's activities, highlighting an upcoming table top exercise modelled after the 1974 storm as well as an active shooter field training exercise. He requested the City's consideration of no longer requiring the LEPC to pay for utilities at the Public Safety Building, arguing the funds could be put to better use building out the space as a state of the art Emergency Operations Center.
- 2) Charlie Lean opined the City was in good hands with Mr. Vaden as the LEPC Chair, arguing it will be hard to replace him when the time comes. Speaking as a Port Commissioner, he noted the tariff that was up for first reading later on the agenda, explaining the Commission sought to build a financial cushion in anticipation of emergency repairs, such as occurred with the WestGold dock last summer. Speaking as a Museum and Library Commissioner, he noted his surprise at AK DOT bringing up the incomplete project of designating the Nome Historic District and explained there was interest at the Commission in taking the project up again.
- 3) Zoe Okleasik thanked the Council for considering the plastic bag ban in the work session earlier. She asked that the Council start small and take into consideration people on food stamps or similar programs when looking a potential bag tax.

UTILITY MANAGER'S REPORT

- A. Activity Report: January 28 February 14, 2020.
 - Assistant Utility Manager Ken Morton noted the IBEW agreement would be on the next Council agenda, updated the Council on the West Nome Tank Farm conveyance process, and the increase in power and water usage system wide due to temperatures being colder than the past few years.
 - Manager Handeland announced that NSEDC Energy subsidy sign-ups will occur in City Hall on February 25, 26, and 27. He explained the Utility would work with people who were unable to make it in during the scheduled time and that the subsidy brings a significant amount of money into the community.

CITY MANAGER'S REPORT

- A. Activity Report: January 28 February 14, 2020.
 - Manager Steckman presented his verbal report apprising the Council of preparations for Iron Dog racers due to Nome within the day and his discussions with Norton Sound Hospital on utilizing their cultural orientation training for City employee onboarding. He noted the trip to DC had been a productive one with a very positive tone.
 - Council Member Topkok asked for clarification on cultural orientation.
 - Manager Steckman explained he was upgrading the HR onboarding process and that every City employee would go through it, along with harassment training. He noted that he was working with NPD to establish better training for dispatchers.
 - Council Member Brown requested future discussion over the LEPC utilities issue.
 - Manager Steckman gave briefed the Council on current scheduling and technology issues being looked at to upgrade the Public Safety Building's training room.

CITIZENS' COMMENTS

1) Charlie Lean explained to the Council that the Port Commission was trying to think outside the box on ways to come up with new revenue, including a potential head tax for cruise ship passengers.

COUNCIL MEMBER COMMENTS

- 1) Council Member Mark Johnson stated he was happy to see the positive rapport between City administration and local news outlets. He recalled a news story from Milwaukee where a young mom was murdered, describing a statement from the police chief there on domestic violence as a decades old multi-faceted and systemic problem. He finished by explaining how nice it was to see new houses being constructed and major remodels happening.
- 2) Council Member Topkok wished everyone a happy Valentine's Day in Inupiaq and expressed her appreciation for the City of Nome's increased interest in partnering with tribes.
- 3) Council Member Brown also expressed his appreciation for the changes, the new HR onboarding process, and the implementation of the new youth representative ordinance.

4) Council Member Doug Johnson – no comments.
