- 2) Paul Kosto introduced himself and summarized several articles highlighting hiring and procedural issues concerning the police departments. He discussed challenges the ambulance department currently faced. Mr. Kosto discussed snow removal and suggested putting the job out to bid to improve efficiencies.

 - Manager Steckman thanked the Mayor and Clerk for meeting him at the airport. He updated the Council on his first two weeks in office and encouraged the Council to use their newly set up city email addresses.

- C. November 2019 Port & Harbor Update.
 - Port Director Baker explained to the Council the WestGold Sheet pile dock repair project was completed under budget and that the funds the Port applied for to complete the Snake River Floats project had been awarded to the Port of Anchorage. She finished by explaining the Arctic Deep Draft Port Project had just passed a significant milestone. She noted the Corps expected to have a draft report for agency review by early January.

CITIZENS' COMMENTS

1) Emily Hofstaedter spoke about the ice rink, noting the volunteers at the ice rink stated that they did not have enough funding to operate all winter.

COUNCIL MEMBER COMMENTS

- 1) Council Member Brown requested a work session at the next regular meeting to discuss possible revisions to the personal property tax code.
- 2) Council Member Mark Johnson welcomed Manager Steckman. He expressed appreciation over the school update and hoped both the positive numbers and the updates continued.
- 3) Council Member Martinson welcomed Manager Steckman and looked forward to working on the property tax ordinance.
- 4) Council Member Reader requested updates on the plastic bag ban, NVAD-NSHC issues, Mr. Ahmasuk's Port concerns, Soldotna's document delivery software, liquor control ordinances, and a snow removal plan.
 - Council Member Brown explained the single use plastics ban was intended to be discussed in January or February.
 - Port Director Baker explained Mr. Ahmasuk's concerns over the national security rhetoric being used in the conversation at the federal level.
 - Council Member Brown explained that Clerk Hammond had reached out to Soldotna and was looking into it and that he would like to address the liquor control ordinances sooner rather than later.
 - Manager Steckman explained he was actively working on snow removal plan and was trying to get a handle on the issues.
- 5) Council Member Topkok explained she would be out of town for the December 9th meeting. She explained the school was starting a K 2 language immersion program. She finished by agreeing on scheduling a work session for personal property taxes at the next meeting.

MAYOR'S COMMENTS AND REPORT

 - Mayor Beneville noted his recent appointment to the chair of the Alaska Conference of Mayors and that he used the position to introduce a resolution urging other municipalities to start their own public safety commissions. He finished by wishing everyone a happy Thanksgiving.
