## **CITIZENS' COMMENTS**

1) Lisa Ellanna expressed hope that NPD receives the attention and staffing it needs to do their jobs.

#### **NEW BUSINESS**

- A. Executive Session on Police Department Issues that Immediate Knowledge of Which Could Have an Adverse Effect on City Finances.
  - Chief Estes and Manager Handeland reviewed the packet of NPD statistics with the Common Council.
  - Council Member Reader expressed concern over the two on / two off schedule, opining that police who don't live in the town are less invested in its well being.
  - Council Member Brown expressed concern that an audit by the insurance company's police professional consultant would affect the City's insurance premium.

Council Member Mark Johnson expressed concern over the hiring of family members in the Police Department.

Mayor Beneville solicited additional comments from Citizens present:

- 1) Henrik Brandt commented on sexual assault case statistics, comparing the period 2005- 2008 and 2008 - 2018.
- 2) Lisa Ellanna stated that the statistics were helpful and that NPD needs more staff to do their jobs. She opined that two on / two off schedules were not good for the community. She argued that when people behave badly there needs to be accountability. Ignoring discipline sets a bad precedent. Ms. Ellanna discussed examples of the Department of Justice taking over municipal police departments and suggested the City contact Tom Tremblay, who worked with Missoula, MT on similar issues.
- 3) Molly Kenick asked if she could start a school club assisting the City Council with a youth perspective. She explained that the youth's perspective is important because the youth will be alive longer. She expressed appreciation for the NPD officers talking with students at school.
  - Mayor Beneville requested a one page proposal detailing her request.

A motion was made by C. Reader and seconded by C. M. Johnson to enter into executive session to discuss police department issues that immediate knowledge of which could have an adverse effect on City finances.

The Council went into executive session at 7:13 PM.

The Council came out of executive session at 10:50 PM.
