## CITIZENS' COMMENTS

- 1) Paul Kosto, President of the Nome Chamber of Commerce, spoke regarding R-19-06-01 and the contract to run the Visitor's Center. He noted the City's fiscal situation but explained that at \$175,000 per year, the operation of the Visitors' Center was still being subsidized by the Chamber of Commerce. Mr. Kosto noted current projects and challenges and requested the Council consider fully funding the Visitors' Center operations.
  - Council Member Brown suggested increasing the budget and negotiating the contract.
  - Manager Handeland requested time to negotiate with Mr. Kosto.
  - Mr. Kosto noted the next board meeting of the Chamber was July 10.
- 2) Ken Hughes thanked the City and State for their efforts on controlling dust in Nome, explaining he can see the difference. However, there's still work to be done, he contended.
  - Manager Handeland asked the citizenry to drive a little slower, noting the substantial difference in kicked up dust when the hospital put in speed bumps in its parking lot.

- Council Member Mark Johnson suggested the Council could do away with the business personal property tax altogether and accomplish the revenue through other means.
- Manager Handeland complicated conversation by asking how the ordinance should define subsistence use and what percentage of subsistence use of the property would allow for the exemption.

- A. Activity Report: June 11 June 21, 2019.
  - Manager Handeland presented his verbal report noting Midnight Sun Festival and Richard Beneville Day highlights, a Police Officer offer of employment tendered, an update on the cemetery and the great job Paul Kudla has been doing, and congratulations to Barb Amarok, the new director of UAF – Northwest Campus. He finished by detailing the emergency repairs needed at the Westgold Dock at the Port.
  - Port Director Baker further explained the split discovered in the sheet pile and the expense and logistics the Port was facing to address the situation.
  - Council Member Mark Johnson asked where the funds would come from.
  - Finance Director Liew explained the expenses were not yet in the budget and would show up as a mid-year amendment. She gave an overview on the fund balances of both the general fund and the port budget.
  - Manager Handeland explained that the sheet pile docks were reaching the end of their life expectancy and that the City could expect larger repairs in the future.
  - Council Member Mark Johnson requested that balance sheets for the general fund and port fund be presented to the Council on a quarterly basis, explaining the information will be needed for the Council to take a deep dive into the budget.
  - Council Member Brown requested the NPD body camera policy be presented in a council packet. He also requested follow up on the over-the-counter property sales ordinance.
  - Manager Handeland explained there were no property disposals scheduled for the next fiscal year and that the current ordinance draft was different than what Council Member Brown was requesting.

- 1) Sandra Medearis asked what was going on with the City Manager search.
  - Mayor Beneville explained the City was still moving forward.
  - Ms. Medearis characterized the matter as a broken record without sound.

- 4) Council Member Reader asked what City Planner Faix meant when she mentioned adding a section about equitable leadership in her staff report at the May 7 Planning Commission meeting. She thanked Manager Handeland for all his hard work and stated she was sorry she missed Richard Beneville Day.
- 5) Council Member Topkok complimented the packet cover artwork and noted that she already missed the calendar tracking the budget process, saying it was helpful for planning purposes. She thanked those that attended the First Alaskans' Institute luncheon. Council Member Topkok finished by reiterating her desire to see more civic engagement among the youth and noted that only Anchorage has a youth commission.

## MAYOR'S COMMENTS AND REPORT

  - Mayor Beneville praised the Bering Sea Lions Club for their chicken BBQ, noting he loves the coleslaw. He congratulated Barb Amarok on being named the new director of Northwest Campus. Mayor Beneville attributed the discount on sheet pile for the Westgold Dock repair to a phone call to Anchorage Mayor Berkowitz and noted the first cruise ship of the season was due in on July 9th. He finished by asking why the City forwent a grant for equipment for NPD.
  - Manager Handeland explained that the grant was put together by a different entity and the City would be responsible for maintaining the grants equipment inventory for the entire region. He explained the City shouldn't take on such a responsibility.
