MINUTES NOME CITY COUNCIL REGULAR MEETING MAY 13, 2019

The regular meeting of the Nome City Council was called to order at 7:02 PM by Acting Mayor Jerald Brown in Council Chambers of City Hall, located at 102 Division Street.

 - Council Member Mark Johnson opined that it was a sad day seeing the old library turned into a marijuana shop.

 - Council Member Brown asked if the work session on May 20th was needed.
 - Manager Handeland summarized the direction he had gleaned from the day's work session as looking for cost efficiencies in the Recreation Center, Public Works, and Cemetery budgets.
 - Council Member Brown opined the public should give input on which services to reduce, if any.
- F. Flyer re: Annual Spring Clean Up.

CITIZENS' COMMENTS

- 1) Jessica and Howard Farley, Jr criticized the City of Nome's permitting process, stating it was a broken system and should be addressed. She cited her recent renovation of a dilapidated house, for which she received a certificate of occupancy. However, the appraiser cited issues which caused the sale to fall through. She requested a refund of all permitting fees and asked how she should proceed.
 - Manager Handeland promised a response by the end of the week, though advised through the City, per Alaska Statute, was under no obligation to refund the permit fees.
- 2) Colby Engstrom described difficulties he experienced with the permitting process around the renovation of Twin Dragon restaurant into a laundromat. He expressed frustration over the City of Nome giving approval and then catching an error. Mr. Engstrom described the costs he was accruing and asked he could move forward.
 - Manager Handeland stated he would respond by the end of the week.
- 3) Lisa Ellanna spoke in support of the substitution version of O-19-02-02. She criticized the ordinance as still not having a mechanism to compel NPD to comply with the Commission and revision of the NPD OPM was not explicitly outlined as a duty of the Commission.

UNFINISHED BUSINESS

A. 0-19-02-02 An Ordinance Amending Chapter 2.30 of the Nome Code of Ordinances to Create a Public Safety Commission, **SECOND READING/PUBLIC HEARING/FINAL PASSAGE**.

For the purpose of holding a public hearing, the Council recessed at 7:37 PM.

Discussion:

- Eric Osborne spoke in support of adopting the ordinance, citing the need for citizenry to be able to trust the police. He opined the previous Chiefs / managers abused the power given to them.
- Triada Stampas commended the process which brought the community to the present. She suggested the Council amend the ordinance to allow the commission greater access to NPD information by request through the City Manager and adopt it as amended.
- Darlene Trigg thanked the Council for their time and suggested annual recommendations be transmitted to the Council around the budgeting time period. She also requested that "in public safety" be removed from the racial equity in public safety, opining the wording was limiting. Ms. Trigg also recommended clarifying the revision process of the OPM, suggesting a critical evaluation of NPD's policies rather than just a review.

The Council reconvened at 7:48 PM.

 - Assistant Utility Manager Morton presented his verbal report, highlighting preparations made to ship a surplus generator to Wrangell, the appraisal of Block 20, the finishing of a meter audit, a work session on potential power generation at Pilgrim Hot Springs. He apprised the Council of current collections efforts.

CITY MANAGER'S REPORT

- A. Activity Report: April 23 May 10, 2019.
 - Manager Handeland updated the Council on city administration noting that the FY2020 was a daily focus and a mill rate increase would likely be needed. He noted the city would be transitioning over to the Quintillion network and expected increased Internet speeds afterwards. Manager Handeland updated the Council on the status of the ACSA bathroom project, explaining there had been some staffing changes at BSDC, but that administration was moving forward in the attempts to get the project underway despite potential timing issues. He finished by reminding everyone that You Call We Haul was coming at the end of the month.

 - Port Director Baker stated the draft feasibility study from Corps of Engineers was out for public comment and available at the Clerk's Office. She encouraged everybody to read it. She noted a setback in the concrete ramp project, as the project will have to go through the NEPA process.
