MINUTES NOME CITY COUNCIL REGULAR MEETING DECEMBER 10, 2018

The regular meeting of the Nome City Council was called to order at 7:13 PM by Mayor Richard Beneville in Council Chambers of City Hall, located at 102 Division Street.

A. November 26, 2018 City Council Special Meeting Minutes.

A motion was made by C. Reader and seconded by C. Brown to approve the November 26, 2018 minutes.

COMMUNICATIONS

- A. Memo of November 28, 2018 from State Assessor McGee to City of Nome re: Questions Concerning the Full Value Determination.
 - Councilman Brown asked how the Full Value Determination (FVD) affected school funding.
 - Joe Caissie with the State Assessor's Office explained that the FVD determined the minimum local contribution to the local school system and how that in turn affected the state contribution. He explained that if the Base Student Allocation (BSA) was \$10,000 and 2.65 mills of the FVD was 2,000 (per student), the State would contribute \$8,000 while the City contributed \$2,000.
 - Councilman Brown suggested the City be diligent in contesting the full value determination, citing the machinery & equipment value being significantly higher than reported in Nome. He suggested doing property tax audits of the companies with the highest value in M&E category.
 - Marty McGee with the State Assessor's Office explained the City would have to prove the local reporting was accurate.
 - Councilman Mark Johnson restated for clarification that a higher number as assessed by the state means the City's contribution goes up in relation to the State Foundation's funding coming into Nome.
 - Manager Handeland asked for clarification on the figures at the top of page 11.
 - Mr. McGee explained the factors were derived from extensive analysis of similar sized communities in Alaska.
 - Council Member Reader asked if the FVD contained exempted property added back in.
 - Mr. McGee explained that wasn't the case with mandatory exemptions; rather, the difference in value was due to alleged undervaluation. He suggested auditing taxpayers to ensure of accurate reporting. He noted he would not add value back if he was sure the locally reported numbers were accurate.
 - Clerk Hammond explained reporting had historically been done on the honor system.
 - Mr. McGee suggested auditing 10 accounts, based on the size of the City's tax roll.
 - Council Member Brown suggested Clerk Hammond issue a PSA and a display ad in the paper.

CITIZENS' COMMENTS

- 1) Lisa Ellanna commented on a recent letter from then-Governor Walker in response to a letter signed by several Nome / Bering Strait entities concerning sexual abuse and assault. She suggested Jodie Potts and Diane Casto as potential outside facilitators willing to assist in determining the scope of a public safety committee. She suggested the City develop a policy on dealing with incapacitated individuals and asked if someone monitors the camera by the Visitor's Center.
 - Manager Handeland explained that, while the camera did not have a dedicated individual monitoring, the feed was being watched.
- 2) Barb Amarok with the Bering Strait Women's Group expressed her appreciation for the City / Nome Police Department attention to the issue of sexual assault, citing trust needing to be restored. She asked the City consider the BSWG for the public safety committee and offered to partner in training.

NEW BUSINESS

• City Manager Handeland presented his written report highlighting upcoming DOT project areas in Nome. He explained a cooperative agreement from 2012 in which the City of Nome agreed to an amount of funding for a local match to the Port Road Improvements Project. He explained an additional amount was needed to close out the project.

A motion was made by C. D. Johnson and seconded by C. Brown to authorize the additional required match of \$30,477, originally authorized by R-12-07-04 for the Port Road Improvements Project.

Lastly, Council Member Johnson called attention to the difficulties businesses faced on Front St due to flood plain regulations and asked that business development be encouraged rather than discouraged.
