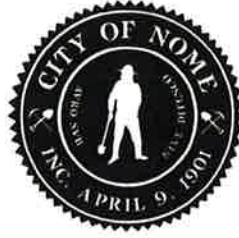

### **NEW BUSINESS**

#### **A. R-18-10-01 A Resolution Canvassing the Results of the October 2, 2018 Municipal Election.**

A motion was made by C. M. Johnson and seconded by C. D. Johnson to adopt R-18-10-01.

##### **Discussion:**

- Clerk Hammond explained the election results and ballot reconciliation documentation, noting minor discrepancies between the numbered ballot stubs and the counted ballots. He surmised that two ballots, not votes, were double-counted somewhere in the spreadsheet and that he was not able to figure out where or why. He also noted that there appeared to be three signature discrepancies in the precinct register that he wasn't able to explain. Clerk Hammond finished by noting the discrepancies were not great enough to change the results of the election.
