CITIZENS' COMMENTS

- Rolland Trowbridge thanked the City of Nome for the business over the past two years.
 He stated TSR treated each vehicle as their own and would like the opportunity to do so
 again in the future.
- 2) Marvin Poyourow thanked the City Council for considering their request for late senior property tax exemption and announced he and his wife were available for any questions.
- 3) Planning Commissioner Sara Lizak spoke in support of adding historic preservation duties to the Planning Commission.
 - Mayor Beneville asked how much extra work was involved.
 - Commissioner Lizak explained that the duties dovetailed with goals present in Nome's Comprehensive Plan, didn't add any onerous extra responsibility, and would qualify the City of Nome for potential grant funding.

- Councilman Culley asked if this process would clearly define what was "historic" and what was "junk" in Nome.
- Councilman Tobin asked if this would give the Planning Commission authority over private property.
- Commissioner Lizak explained the ordinance would give them authority to create a plan with community input.
- Mayor Beneville expressed concern the extra duties might impede current momentum of the Planning Commission.
- Councilman Andersen requested that three buildings be put up for abatement at the 7/25/16 Regular City Council meeting.
- Councilman Culley suggested a field trip to view the properties in question.
- Councilman Tobin requested photos.
- 4) John Handeland stated that to him, the historic preservation ordinance was unexpected and he wondered why the duties were not being placed on the Museum and Library Commission.
 - Manager Moran explained the ordinance had been discussed for months and the Museum Director and Planning Commission all agreed that the requirements better fit the Planning Commission's scope.

- Manager Moran thanked Trinity Sales and Repair for their work over the previous two years and explained that Nome Machine Works bid came in \$5/hour lower.
- Mayor Beneville clarified the contract was for one year with potential to extend an additional year upon mutual consent.
- Councilman Andersen requested notification of the City's position on extension prior to consenting to the extension. He also requested a detailed log be kept for each vehicle to ascertain how much money is being put into each vehicle and on what.
- Manager Moran noted that the Finance Department and TSR had created a system to track vehicle expenses.
- Councilman Andersen noted the City reserved the right to bring vehicles to a different mechanic if desired. He announced that one of his sons works at Nome Machine Works.

- Manager Moran explained the process was the same as R-16-07-07. He stated the Fire Chief was happy with TSR, but that the City of Nome had to award the contract to the lowest qualified bidder.
- Councilman Brown asked if there was any reason either bidder could be considered unqualified.
- Manager Moran answered no, explaining the issues in 2014 centered on zoning rather than qualifications.
- Mayor Beneville asked if the same company needed to get all three contracts.
- Manager Moran stated they didn't; historically different companies held separate contracts for the different vehicle fleets.
