# **MINUTES** NOME CITY COUNCIL **REGULAR MEETING** May 23, 2016

The regular meeting of the Nome City Council was called to order at 7:02 PM by Mayor Beneville in Council Chambers of City Hall, located at 102 Division Street.

### **COMMUNICATIONS**

- A. Letter of April 1, 2016 from Sarah Huntsinger to Nome City Council re: Thank You for Donation of Tables and Chairs.
- B. Letter of May 11, 2016 from Norton Sound Health Corporation to Nome City Council re: Request to Waive NSHC's Failure to Meet Application Deadline for Sales Tax Exemption.
  - Councilman Andersen asked when the Council would be taking up this matter.
  - Manager Moran stated the application was denied, though the Council could waive the failure to submit a timely application if they so desired.

A motion was made by C. Brown and seconded by C. Culley to approve the waiver request beginning on July 1, 2016.

#### Discussion:

- Finance Director Liew clarified that sales tax has not been collected by vendors since January.
- Councilman Andersen noted the letter requested the refund of all previously paid sales tax.
- Manager Moran clarified NSHC might have meant that they don't want to be invoiced for unpaid sales tax.
- Councilman Culley stated it might be easiest to handle if NSHC were to pay sales tax for six months going forward.
- Councilman Andersen asked how much sales tax was owed.
- Director Liew stated they were still gathering data and couldn't provide a specific figure.
- Manager Moran reiterated that they hadn't paid sales tax at all.
- Councilman Culley reiterated that the sales tax exemption was free money and it was the applicant's responsibility to ensure paperwork was submitted on time.
- Utility Manager Handeland stated the billing would be easier if the exemption were granted for January to June, rather than July to December.

The motion was withdrawn by C. Brown.

A motion was made by C. Brown and seconded by C. Culley to approve the sales tax waiver request for a total of six (6) months, effective January 1 through June 30 of 2016.

### Discussion:

- Councilman Andersen stated the question was not whether they qualify, but whether a penalty should be assessed.
- Councilman Culley noted the Lutheran Church example, where the deadline was missed and a six month penalty period was assessed.
- Mayor Beneville asked for an estimate on the utility sales tax.
- Manager Handeland stated he gave Director Liew an estimate of \$7,500.
- Councilman Andersen asked if the City was missing the boat on other accounts as well.
- Councilman Brown noted the original exemption list that went out, as well as a reminder a month ago.
- Clerk Hammond said that the original list went out in February.

#### **CITIZENS' COMMENTS**

- 1) Deb Trowbridge thanked the Council for considering the funding request from Kawerak Head Start.
  - Councilman Culley noted that the numbers were different on each letter submitted, which decreased the credibility of each letter.
  - Ms. Trowbridge stated the letter was prepared in her absence.
  - Councilman Brown asked if every dollar was leveraged into five dollars through Head Start funding.
  - Ms. Trowbridge explained that for every four dollars in federal funds, Kawerak had to match one dollar to demonstrate community support.
  - Councilman Brown asked for a justification on the discrepancy between per pupil costs at Nome Preschool Association and Head Start.
  - Councilman Andersen asked why the indirect costs were listed in the letter.
  - Councilman Culley stated that early childhood education funding wasn't mandatory, then reiterated the differences in costs between Nome Preschool and Head Start.
- 2) Shawn Arnold noted it was the last week of the school year and outlined the graduation schedule. He noted there were 34 graduating seniors and that Nome Public Schools had a 90 percent graduation rate.
- 3) Jennifer Reader stated the Memorial Day Parade would be starting at 10:00 AM on Monday and would go from the Polar Café to the Cemetery and then end at the Snake River for the laying of the wreath.

### **UTILITY MANAGER'S REPORT**

- Utility Manager Handeland distributed a letter from NJUS to AKDOT&PF requesting coordination on the Bering Street Rehabilitation Project, reasoning he wouldn't want to pave it, only to tear it up shortly thereafter for a local repair project.
- Manager Handeland briefed the Council on the turbine blade repair project.
- Manager Handeland briefed the Council on this year's fuel purchase bond, explaining a
  revenue bond would have to be issued after July 1 to meet repayment schedule per Alaska
  Statute. He anticipated a \$4.5m to \$4.7M figure.
- Eureka would be sending loss control personnel for their annual briefing on loss control and safety.
- The utility would be conducting a spill drill per DEC requirements on Thursday.
- The utility was working on running water to the Cemetery building.
  - Mayor Beneville thanked Manager Handeland for the "Story 49" concerning the White Alice Towers.

### **CITY MANAGER'S REPORT**

- Manager Moran informed the Council that seasonal Port vacancies had been filled.
- Manager Moran updated the Council on three changes made by the Museum and Library Commission: 1) a Fordson Tractor was accepted into landscaping from donor Fred Moody; 2) Residents without leases or utility bills will be allowed a library card with a social service agency sponsoring them; and 3) The RAP material will not be applied to the portion of the lot that may be seeded in the future.
- Manager Moran briefed the Council on three projects: Arsenic Park fencing, a dog park, and a City campground.

- Manager Moran invited the Council and the Public to the White Alice Picnic on May 27<sup>th</sup> and the Memorial Day parade on May 30<sup>th</sup>.
  - Mayor Beneville asked if parks in town were locked at night.
  - Manager Moran replied in the negative, but then stated the subject was currently under discussion, given an uptick in vandalism and bullying at the new playground.
  - Councilman Culley asked if the bushes at Arsenic Park could be clear cut, giving better visibility and trapping less trash.
  - Mayor Beneville suggested a resolution against bullying.
  - Councilman Culley agreed; though he felt it wouldn't be effective without significant attention.
  - Councilman Andersen requested Lot 5A of Block 50 be placed on the abatement list, stating it was already on the foreclosure list. He suggested it may have been assessed too highly.
  - Councilman Andersen asked about cleaning up junk vehicles.
  - Manager Moran explained the process, noting the form was available at City Hall. He stated the only time the City hauled was during U Call, We Haul.
  - Councilman Culley asked if the City Road Crew could lift the vehicles to help drain the fluids.
  - Councilman Andersen suggested the water truck water the roads daily, perhaps even twice a day during the dry spells.
  - Mayor Beneville asked about the \$1.6 million appropriation in the State capital budget.
  - Port Director Baker stated it was tenuous, but still there.
  - Per Councilman Brown's request, Director Baker outlined the next years' projects at the Port.

- 1) Councilman Culley requested the Citizenry of Nome give input on the Bering Street Rehabilitation project, stating it was important to get it right the first time, given the State's fiscal situation. He also stated that the Editor of *The Nome Nugget* went too far in her latest editorial, describing it as disappointing.
- 2) Councilman Green asked why the crew was steaming on 4<sup>th</sup> Ave.
  - Utility Manager Handeland explained it was to determine where the laterals were.
- 3) Councilman Brown requested a cost/benefit analysis of the lighting efficiency project the City Manager cut from the budget, as well as the discussion on excise taxes brought back to the table.
- 4) Councilman Andersen agreed with Councilman Culley and asked the Editor of *The Nome Nugget* to write a letter to the Council to address any concerns she might have.

#### **MAYOR'S REPORT**

 Mayor Beneville agreed that a letter would be a better way to address concerns from The Nome Nugget.

- Mayor Beneville briefed the Council on his participation in an Institute of the North forum, as well as a tourism training happening at the Mini Convention Center.
- Mayor Beneville reappointed Robert Cahoon to the Planning Commission.

A motion was made by C. Culley and seconded by C. Brown to confirm the Mayor's appointment.
