### **USACE** awards construction contract for portion of Port of Nome Modification Project

JOINT BASE ELMENDORF-RICHARDSON – Today, the U.S. Army Corps of Engineers – Alaska District awarded a construction contract for the first portion of the Port of Nome Modification Project in Nome, Alaska.

Kiewit Infrastructure West Co. of Vancouver, Washington, will construct Phase 1A of the Port of Nome Modification project. Funded by the Infrastructure Investment and Jobs Act, formerly known as the Bipartisan Infrastructure Law, this construction contract award is valued at about \$399.4 million.

"A robust and efficient transportation hub at Nome is foundational to the long-term viability of surrounding communities in the region," said Col. Jeffrey Palazzini, commander of the U.S. Army Corps of Engineers – Alaska District. "We are committed to assisting the City of Nome by providing a reliable solution that improves the port's navigation efficiency."

Phase 1A is the first of four phases of the required construction to build the Port of Nome project. The first phase of the project will construct a 1,200-foot causeway extension with about 600 feet of dock face. Following this portion of the project, the Phase 2 dredging of the deep and outer basins up to minus 40 feet is next scheduled for construction. The City of Nome is the non-federal sponsor for this project.

The entirety of the harbor expansion project aims to provide larger vessels with improved access to Nome's existing harbor and creating a new deep-water basin at a depth of minus 40 feet. Dredging is required to deepen and maintain both basins and associated navigation channels. Currently, ship transportation is limited by existing depths in the outer basin of minus 22 feet. This depth is inadequate to safely accommodate vessels of drafts greater than about 18 feet.

The new port project will serve research and public safety purposes as well as an important pivot point for the nation's military presence above the Arctic Circle. The Port of Nome is a regional hub located on the Seward Peninsula and adjacent to Norton Sound, which is centrally located along the western coast of Alaska. Nome has no access to major road systems and is approximately 545 miles northwest of Anchorage.

USACE's history in Nome dates to the construction of the original harbor in 1917.

#### Administration:

Congestion at staging and laydown areas have been constant this season with the movement of a large amount of project equipment, gravel, rock and various materials brought not only into Nome, but transshipped throughout the region. The dock schedules are modified each day to accommodate vessel schedule changes resulting from weather, mechanical failures, rock availability and evolving construction schedules. Aug and Sep contain the majority of the cruise ship and research vessel traffic for 2025, adding to the dock congestion at this mid-way operating point. As the facility continues to get busier, the imperative for the additional dock space built by the port expansion becomes very clear.

As most have heard, the USCG Commandant, Admiral Kevin Lunday, and a 20-person entourage, were in Nome for 2 hours on 9 Aug 2025 to tour the port facility and meet with local leaders. Although brief, both the tour and discussion were very productive, generating dialogue in support of the expansion of the port facility, and how the project will be beneficial to the USCG Arctic fleet. (see attached City press release for more details and a list of the primary attendees.)

### Causeway:

### <u>Arctic Deep Draft Port – Port of Nome Modifications (Construction Bid Award):</u>

As most have heard, the Corps of Engineers (USACE) Alaska District awarded Phase 1A of the Port of Nome Modifications project to Kiewit Infrastructure West, per the attached press release. This is a milestone achievement for the project, and represents a key marker in realizing construction of the concerted effort put forth to expand the port facility.

Execution of the construction contract will take several weeks, followed by submittals and RFI's to City and USACE designers. Updates will be provided as the project progresses and a biweekly meeting schedule is established.

#### Local Service Facilities (LSF) Inspection Integration:

Contract services with the City LSF designers will continue for responding to submittals and RFI's, along with the necessary onsite inspection during sheet pile construction in summer 2026.

<u>U.S. DOT Maritime Administration (MARAD) – Port Infrastructure Development Program (PIDP) Grant Pre-Award:</u> Discussions continue with program staff on the remaining pre-award requirements for this grant. This will then allow the \$11.25M grant agreement to be executed, along with a separate funding agreement for the \$1.025M that Rep Peltola successfully placed into the FY2025 USDOT budget to supplement the PIDP award to Nome.

#### Harbor:

### Inner Harbor CAP 107 Study (Deepen/Widen the Inner Basin):

The Alaska District continues to recommend a General Investigation (GI) Study. We continue working with the project team on next steps, including the estimated local cost-share and proposed schedule (as well as remedies through the CODEL). Information has been submitted directly to USACE Headquarters regarding the failure to adequately address the concerns of this project in a timely manner, before the feasibility budget was fully expended, and 3-year timeline was exhausted.

### **Snake River Moorage Facility:**

Coordination with USDOT BUILD staff continues for the pre-award process for this grant award. Multiple submittals are necessary to meet compliance required for signing the grant agreement. (Pre-award requirements for this project are similar to those tied to the USDOT MARAD/PIDP award.)

### **Port Industrial Pad:**

### West Nome Tank Farm (WNTF) - Property Conveyance:

Although the conveyance package was signed by the Mayor in May 2025 and returned for federal/state signature, the USAF again made further changes which now require the documents to be resigned by the City. We have recently received the final documents, and as the changes reflect only one Alaska Statute citation and formatting edits, have been determined as nothing substantive. The documents will be resigned by the City and returned to the USAF and ADEC for final execution.

On a separate note, a contractor for the USAF (AF) was in town on 9 July 2025, and did a site visit with NJUS, Public Works and Port staff regarding boring locations for the ongoing sampling the AF is required to perform. The large quantity of locations was reduced to ensure they did not conflict with buried utility infrastructure. Also, the proposed boring sites for City-owned lots 2 and 3 were put on temporary hold, until the AF can share the long-term plan for these sites as there is potential conflict with shore-side development associated with the Snake River Moorage Project. A meeting is planned for the week of 21 July 2025 to discuss in more detail. (Update: revised site boring plans are forthcoming from the USAF contractor.)

### Thornbush Laydown Site Development (TBS):

A Rough-Order-of-Magnitude (ROM) cost estimate is still being investigated, including alternatives to perform incremental work as material available and funds allow. Funding opportunities continue to be evaluated in an effort to complete development of the remaining acreage in a cost-effective manner. The pad remains in a constant evolving state, as individual user and contractor storage needs are considered and efforts made to maximize the usable surface.

### Port Rd. Improvements (ADOT Project cost-shared with City):

This state STIP project has been postponed to approximately 2030 to avoid conflicting with the heavier truck traffic during the port expansion, and to facilitate a more productive repair following the project.

#### **FEMA DR4672 Merbok Recover Projects:**

### Cape Nome Jetty Repair:

Substantial Completion of this project was achieved on 20 July 2025, with final close-out submittals by 4 Aug, and asbuilt drawings submitted on 8 Aug. A site-visit inspection was done on 21 July 2025, by PND's onsite inspector, with work identified as being built per project design and specifications, and deemed 100% complete. The contractor was able to beat the estimated project schedule by 60 days, and was fully demobed from Nome by

#### **Seawall Repairs:**

Storm repairs to the east end of the Nome Seawall have been budgeted by FEMA, and will be bid out to local contractors to perform the work. A bid package is being developed using the SOW prepared by FEMA inspectors, and verified by City Engineers. Advertising is expected in Feb/Mar 2026, with work completed by 31 July 2026.

### Causeway Road/3 Docks Repairs:

Additional road/dock repairs are anticipated to be performed before freeze-up to replace lost material along the road and all 3 Causeway docks. This will meet the scope of work identified from storm damage, reduce future loss, and improve both the subsurface and surfacing in the busiest traffic areas on the Causeway.

### Causeway Utilities (under bridge) Repairs:

Nearly all of the storm repairs to the under-side of the bridge have been completed, by the various responsible entities, with the exception of NJUS. Although a portion of their utility line work has been done, several materials are still on backorder with suppliers. As the scaffolding was removed by the USACE contractor, this final portion of the work will be done during winter, when ice provides a more suitable and stable platform for access.

### **USACE** awards construction contract for portion of Port of Nome Modification Project

JOINT BASE ELMENDORF-RICHARDSON – Today, the U.S. Army Corps of Engineers – Alaska District awarded a construction contract for the first portion of the Port of Nome Modification Project in Nome, Alaska.

Kiewit Infrastructure West Co. of Vancouver, Washington, will construct Phase 1A of the Port of Nome Modification project. Funded by the Infrastructure Investment and Jobs Act, formerly known as the Bipartisan Infrastructure Law, this construction contract award is valued at about \$399.4 million.

"A robust and efficient transportation hub at Nome is foundational to the long-term viability of surrounding communities in the region," said Col. Jeffrey Palazzini, commander of the U.S. Army Corps of Engineers – Alaska District. "We are committed to assisting the City of Nome by providing a reliable solution that improves the port's navigation efficiency."

Phase 1A is the first of four phases of the required construction to build the Port of Nome project. The first phase of the project will construct a 1,200-foot causeway extension with about 600 feet of dock face. Following this portion of the project, the Phase 2 dredging of the deep and outer basins up to minus 40 feet is next scheduled for construction. The City of Nome is the non-federal sponsor for this project.

The entirety of the harbor expansion project aims to provide larger vessels with improved access to Nome's existing harbor and creating a new deep-water basin at a depth of minus 40 feet. Dredging is required to deepen and maintain both basins and associated navigation channels. Currently, ship transportation is limited by existing depths in the outer basin of minus 22 feet. This depth is inadequate to safely accommodate vessels of drafts greater than about 18 feet.

The new port project will serve research and public safety purposes as well as an important pivot point for the nation's military presence above the Arctic Circle. The Port of Nome is a regional hub located on the Seward Peninsula and adjacent to Norton Sound, which is centrally located along the western coast of Alaska. Nome has no access to major road systems and is approximately 545 miles northwest of Anchorage.

USACE's history in Nome dates to the construction of the original harbor in 1917.

Nome, Alaska – As national security and geopolitics demand greater United States presence in the Arctic, Nome is on the forefront of shaping the region's future as one of Alaska's most strategically important communities. The Port of Nome, the Nation's first deep draft port is poised to serve as an economic pillar for the region, advancing and supporting scientific research, national security, fisheries, maritime safety and Arctic tourism.

This port is critical to our national security, commerce, and the Coast Guard's mission in the region, and I'm committed to supporting the infrastructure and partnerships needed to keep it strong" said Chairman Mike Ezell.

"We are honored to welcome Acting Commandant Lunday, and Representatives Ezell and Patronis to Nome. The City of Nome stands ready to protect the Nation's interest in the Arctic. I want to thank Senator Dan Sullivan, Senator Murkowski, and Representative Nick Begich for securing these important leadership visits to advance our Nation's Arctic deep draft port" said Mayor John Handeland.

The U.S. Army Corps of Engineers Alaska District is actively reviewing proposals to construct Phase 1A of the Port of Nome Modification Project, known as the Arctic Deep Draft Port at Nome. This portion of the project will construct a 1,200-ft Causeway extension with a 600-ft dock, initiating development of this critical maritime infrastructure project in the U.S Arctic.

The Port of Nome will serve as the export site for the Graphite One mine, located on the north side of the Kigluwait Mountains. The Department of Defense awarded Graphite One a \$37.5 million grant to develop the graphite mine site under the Defense Production Act. On March 20, 2025, President Trump enacted an Executive Order, "Immediate Measures to Increase American Mineral Production" to develop the domestic critical minerals supply chain.
