ORDINANCE NO. 17-09-02 (Amended)

AN ORDINANCE AMENDING TITLE 5 (BUILDINGS & CONSTRUCTION) AND TITLE 18 (ZONING) OF THE NOME CODE OF ORDINANCES TO UPDATE THE DEFINITION OF A "JUNK MOTOR VEHICLE"

WHEREAS, the City of Nome ("City") recognizes the need to maintain clear, concise, and consistent definitions within its Code of Ordinances; and,

WHEREAS, Title 5 (Buildings and Construction) of the Nome Code of Ordinances currently includes a definition for a "junk motor vehicle"; and,

WHEREAS, Title 18 (Zoning) of the Nome Code of Ordinances currently includes the same definition for a "junk motor vehicle"; and,

WHEREAS, at its meeting of August 28, 2017, the Nome City Council asked that the definitions in Title 5 and Title 18 be relaxed.

NOW, THEREFORE, BE IT ORDAINED, that the City Council formally amends both Title 5 and Title 18 as follows:

Section 1. Amendment of Chapter 5.40.020. Chapter 5.40.020 of the Code of Ordinances of Nome, Alaska is hereby amended to read as follows [deleted text is ~~overstruck~~; added text is underlined]:

Chapter 5.40.020
DEFINITIONS

"Junk motor vehicle" means a discarded, dismantled, wrecked, scrapped or mined passenger motor vehicle or parts thereof, an unregistered motor home not connected to water and/or sewer, or a passenger motor vehicle other than an on-premises utility vehicle which is allowed to remain unregistered and uninsured for a period of thirty days from the date of discovery.

Section 2. Amendment of Chapter 18.20. Chapter 18.20 of the Code of Ordinances of Nome, Alaska is hereby amended to read as follows [deleted text is ~~overstruck~~; added text is underlined]:

Chapter 18.20

DEFINITIONS

"Junk motor vehicle" means a discarded, dismantled, wrecked, scrapped or mined passenger motor vehicle or parts thereof, an unregistered motor home not connected to water and/or sewer, or a passenger motor vehicle other than an on-premises utility vehicle which is allowed to remain unregistered and uninsured for a period of thirty days from the date of discovery.

Section 2. Effective Date. This ordinance is effective upon passage.
