WHEREAS, the Nome Joint Utility Board determined application should be submitted to the Alaska Department of Environmental Conservation Clean Water Fund Program to finance various infrastructure improvements to water and sewer systems, including replacements, extensions and enhancements; and

WHEREAS, the Alaska Department of Environmental Conservation has Alaska Clean Water and Alaska Drinking Water Fund loan programs with terms up to 20 years with no prepayment penalties to provide low interest (1.5%) financing to communities for water and sewer systems and NJUS submitted project funding questionnaires to be included on the Intended Use Plans for these ADEC programs; and

WHEREAS, following acceptance of NJUS' application, and pending availability of loan program funds, ADEC will be prepared to enter into an Agreement for Project # (pending) – USDA Wastewater Loan Refinance - \$588,480, and by Resolution 18-08 the Nome Joint Utility Board recommends the loan, expected to be offered, be accepted; and


NOW, THEREFORE, BE IT RESOLVED that the Nome Common Council approves and accepts an ADEC Clean Water Fund Loan for the refinancing of USDA loans which funded wastewater system improvements in the amount of \$588,480 with a up to 20 year payback at 1.5% interest, and authorizes the Utility Manager as Chief Operating Officer of the Utility to execute any and all documents that may be required by the Department to reflect the indebtedness, the terms of its repayment, and any security thereof, including but not limited to an agreement for the loan and a promissory note.

WHEREAS, the Utility Board determined application should be submitted to the Alaska Department of Environmental Conservation Drinking Water Fund Program to finance various infrastructure improvements constructed to water and sewer systems, including replacements, extensions, enhancements and loan refinancing of related efforts; and,

WHEREAS, 5he Alaska Department of Environmental Conservation Alaska Clean Water & Alaska Drinking Water Fund loan programs offers terms up to 20 years with no prepayment penalties to provide low interest (1.5%) financing to communities for water and sewer systems; and

WHEREAS, NJUS submitted questionnaires to be included on the Intended Use Plan (IUP) for the ADEC Clean Water Loan program. ADEC completed the scoring process and published the SFY19 Priority List. While funding for USDA Loan Refinance (Sewer) in the amount of \$588,480 was not allocated, NJUS was invited to apply after September 14, 2018 for potentially available funds to be distributed on a first-come, first-served basis; and

WHEREAS, Refinancing higher interest rate USDA loans (4.25 % - 4.875%) with ACWF (1.5% at 20 years) funds will save more than \$300,000 in finance charges.

NOW THEREFORE BE IT RESOLVED that the Nome Joint Utility Board requests the Nome Common Council approve and authorize acceptance of a loan for \$588,480 through the ADEC Clean Water Fund Loan Program for refinancing USDA sewer system related improvements with a 20 year payback at 1.5% interest, and authorize the Utility Manager as Chief Operating Officer of the Utility to execute any and all documents that may be required by the Department to reflect the indebtedness, the terms of its repayment, and an security thereof, including but not limited to an agreement for the loan and a promissory note.

USDA LOAN REFINANCING UTILIZATION OF ALASKA ADEC DRINKING WATER & CLEAN WATER LOAN PROGRAMS

The Utility received funding from USDA Rural Development for utilidor replacement and upgrade of water-wastewater mains in the community. For the funding USDA required the Utility to take out a loan through their agency as part of the financing to receive a grant. Three separate grants/loans were accepted (1998, 2005 and 2006).

USDA loans carry interest based on federal funds rates; for the three loans: 4.785%, 4.25%, and 4.375%. While the 2005 loan was "snuck through" on a 20-year schedule, the other two (and standard agency practice) is that they are based on a 40-year period. Except for the small loan on the 20-year schedule, interest paid over time exceeds the actual principal borrowed. Based on the interest rates and long amortization, payments have pretty much covered the high interest only and we have barely made a dent in the principal. The manager has on occasion brought up the potential these notes should be refinanced and did investigate commercial (bank) financing but did not find this to be much more favorable.

In February, USDA sent us a "graduation letter" suggesting that we seek out alternate sources for financing, and to pay off USDA. With this, we determined to submit questionnaires to ADEC with the recent cycle for accepting projects to be considered under the low interest Alaska Drinking Water and Alaska Clean Water Loan Programs. Our requests were reviewed and included on the Intended Use Plans.

Funding (\$882,700) is available under the DWF program, and we may apply now. We are listed on the CWF program list (\$588,480), but must wait until after September 24 to see what funding, if any, has not been claimed by projects higher up on the IUP list. If as in the past, we believe there is high likelihood the CWF program will have residual funds to process our need.

The funding available through the DWF and DWF programs carries a service charge of 1.5% and can be amortized over up to 20 years. Based on our analysis, the potential interest savings by refinancing the three USDA loans through ADEC approaches \$700,000 based on new 20-year terms. We will evaluate the systems to confirm 20 years is appropriate, and potentially shorten (which would increase yearly payments but further reduce interest expense).

RECOMMENDED ACTION:

That the Utility Board adopt Resolutions 18-07 and 18-08, which forwards the recommendation to the City Council to approve the refinancing opportunity.


