RESOLUTION NO. R-20-01-06 (amended)

A RESOLUTION ALLOCATING THE 2019 NSEDC END-YEAR COMMUNITY BENEFIT SHARE FUNDS

WHEREAS, on November 4, 2019, Norton Sound Economic Development Corporation (NSEDC) informed the City of Nome (City) that it was generously distributing \$200,000 as the 2019 end-year Community Benefit Share (CBS); and,

WHEREAS, on December 13, 2019, the City Clerk published the first of a number of public notices detailing the process by which applications for funding would be accepted; and,

WHEREAS, twenty-seven (27) proposals were submitted to City Hall by the deadline of 5:00 PM on Thursday, January 9, 2020; and,

WHEREAS, the City Council then heard accompanying presentations at a public work session held on Monday, January 13, 2020.

NOW, THEREFORE, BE IT RESOLVED by the Nome City Council that the following projects are hereby allocated Community Benefit Share funding in the following amounts:
